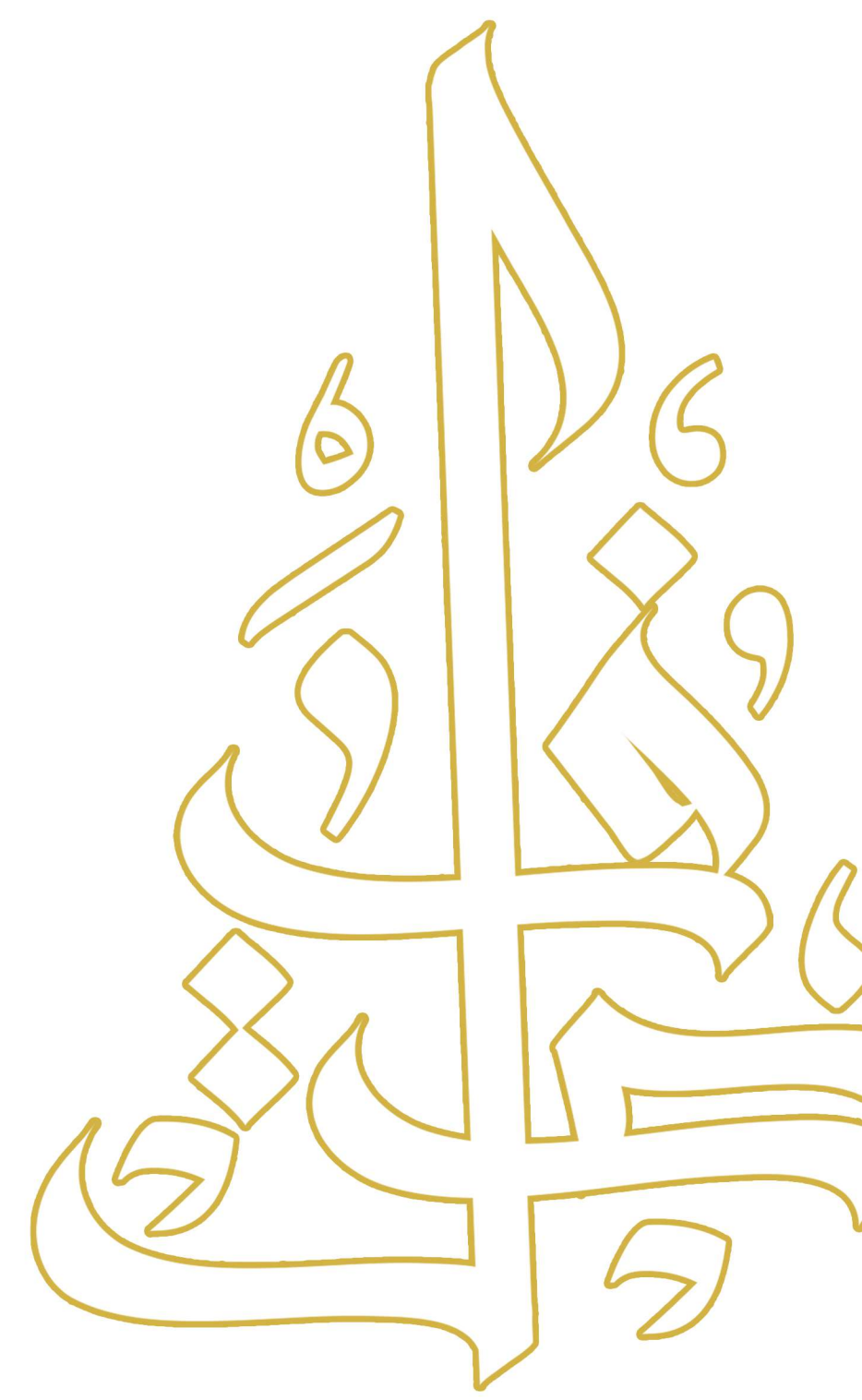

Legal advice :
